  - Additional financial resources (\$1,160,340 over 3 years) for the overall financing plan for scale-up of CCM of diarrhea with the oral rehydration salts and zinc (Supplement the financing provided by MI)
- 3. Start MEO for implementation of home-based newborn care**
  - RAS (funding acquired H4)
- 4. Search for funding for the extension of CCM of IRA**
  - Need technical support for drafting of a proposal to be submitted to potential donors
- 5. Finalize the definition of a profile of the ASBC adapted to the activities of CCM**
  - RAS (funding already acquired from UNICEF)
- 6. Adoption of the health-promotion policy**
  - RAS (funding already acquired from MoH)
- 7. Elaboration and adoption of the strategic plans of public health and child survival**
  - Need support in elaborating the child survival plan (UNICEF WCARO)
- 8. Establishment of adequate mechanisms for resupply of the ASBC in drugs**
  - Need technical and financial support
- 9. Continuation of the MOE of the CCM of malaria, of diarrhea, of malnutrition, of the care of a newborn and of IRA**
  - Need for financial resources (to be determined)
- 10. Make amoxicillin available in the treatment of pneumonia (in place of cotrimoxazol)**
  - Need financial resources for the purchase of amoxicillin (to be determined)
- 11. Extend the CCM of the IRA in nine districts of the northern regions and center-north**
  - Need financial resources
